MEMBERSHIP ELIGIBILITY

A firm must have a location within Spokane and Kootenai Counties to be eligible for membership.

Member firms that must hold a valid business license or industry certification as a requirement or qualification to be engaged in their chosen primary business as required by the States of Washington and Idaho will provide such approved license or industry certification for review if requested by the Board of Directors.

EWI of Spokane consists of a diverse group of businesses, governmental agencies, non-profit enterprises or associations actively engaged in the conduct of business that meet all requirements of the Corporation and the Chapter ("Member Firms").

EWI of Spokane classifies our member firms by the North America Industry Classification System (NAICS) Codes and Titles. Member firms are responsible for ensuring the accuracy of their assigned NAICS Codes and Titles, and Primary Business Descriptions documented in the EWI of Spokane member firm rosters and listings.

The NAICS Code and Title may be the same for firms within the Spokane Chapter. However, the Primary Business Description must be different. The Recruitment & Retention Director refers to the NAICS Code and Title Classification, and Primary Business Description for the evaluation of a proposed member firm.

ATTENDANCE REQUIREMENTS

Each member firm must be represented by a representative or an executive at seven (7) meetings within the Chapter year and must not have three (3) consecutive unexcused absences at any time during their term of membership.

A representative must attend a minimum of six (6) meetings during the Chapter year. (See Member Guide for complete attendance requirements.)

EWI MEMBERSHIP FEES

Corporate Fees:

- Admission Fee \$50.00 (per firm one time only)
- Annual Dues 1st Rep \$180.00 / 2nd Rep \$130.00 / 3rd+ Rep \$105.00

Chapter Fees:

- Admission Fee \$25.00 (per firm one time only)
- Member Firm/1st Representative Dues \$165.00
- Additional Representative(s) \$35.00
- Name badge Fee (per representative one time only) \$15.00

SUMMARY OF ANNUAL DUES AND FEES

Firm and 1st Rep:

• \$435.00 (EWI member firm dues & name badge)

Additional Rep(s):

• 2nd Rep \$180.00 / 3rd+ Rep \$155 (additional rep fee, annual dues, & name badge)

Monthly Meeting Fees:

- \$35 per Month per Representative except Firm Recognition/Executive **Appreciation Night**
- Firm Recognition Nights/Executive Appreciation Nights- \$40 (2 annually)
- Monthly meeting fees are billed quarterly
